CIVIL MARRIAGES

Bride, groom and witnesses must arrive in Playa del Carmen at least three full working days (Monday-Friday) prior to the wedding ceremony to meet with the wedding coordinator and submit all documents. The bride & groom's information form must be filled out and submitted at least 30 days prior the ceremony date. This form will be provided by Blue Venado Weddings.

All documents in photocopy:

- Marriage application form filled (we will provide it)
 - Birth certificates, IFE or CURP (both sides)
 - Passport
 - Prenuptial blood test certified by the doctor. (HIV , STD 's and blood type)
Results are ready within 24 Hrs.
 - IFE or Passport of all witnesses.

- Divorce letter or a photocopy of divorce.
 - If one or both parties are divorced, present a copy of request you have to be translated into spanish and apostilled.
 - Please note that if the bride has-been divorced less than a year, she must take a mandatory pregnancy test.

*All original documents must be submit on the wedding day.

IMPORTANT:

If the bride or groom's nationality is Mexican, copy the birth certificate and ID is necessary in addition. Please do not send any original document by mail or courier; however you can send them by E-mail. Ceremony cannot be performed unless all required documents are received. No exceptions are granted.

CIVIL MARRIAGES

Foreigners

Bride, groom and witnesses must arrive in Playa del Carmen at least three full working days (Monday-Friday) prior to the wedding ceremony to meet with the wedding coordinator and submit all documents. The bride & groom's information form must be filled out and submitted at least 30 days prior the ceremony date. This form will be provided by Blue Venado Weddings.

All documents in photocopy:

- Marriage Application Form filled (we will provide it)
- Passport and FMM (Multiple Migratory Form) (both sides)
- 4 legal witnesses. All must submit copy of passport and FMM (Multiple Migratory Form). If the witnesses are mexicans, submit a copy of IFE or passport.
- Prenuptial blood test certified by the doctor. (for HIV, STD 's and blood type)
Results are ready within 24 Hrs.
- Divorce Letter or a photocopy of divorce.
- If one or Both parties are divorced, present a copy of request you have to be translated into spanish and apostille.
- Please note that if the bride has-been divorced less than a year, she must take a mandatory pregnancy test.

(If you want to have your parents names in the certificate, it is necessary the birth certificate of both)

*All original documents must be submit on the wedding day.

IMPORTANT:

It is very important you check in your city hall what the requirements are to register your marriage, some cities require the marriage license to be translated and apostilled, some of them need this requirement to be done in México and some others allow the couples to get it in their own cities. We will highly recommend you to check first all of this information to get a clear budget of what the civil marriage will cost you finally.
